## Is a dental school right for Utah?

Members of the UAGD will be asked to take a stand on this important issue in the near future. As dentists concerned with the welfare of the whole profession's status in our state, it behooves us to become familiar with the issues at stake and form an opinion. Several privately sponsored events have been taking place around the state in order to recruit support for the dental school. Hopefully, many of us have had discussions surrounding this issue. It's easy to understand that none of us live in a bubble. Our little offices are not insulated from the winds of politics. Each of us is affected by these changes.

The state seeks the guidance of the profession in how to spend taxpayer dollars. Your participation does make a difference-especially if the entire UAGD stands together.

Some of the issues raised in regard to the potential dental school include:

Access to care for the uninsured or Medicaid covered people.

Perspective dental students from Utah are being educated as dentists and coming back here anyway

Additional dental access in a state already at high ratios of dentists: population.

Opportunity to teach at a dental school for clinicians in Utah

Dental schools around the country have shut down for a reason and opening new ones have met with difficult progress

As these issues are discussed, we believe that our greatest strength will be in united opinion as to how to proceed. Confusion on the part of those who should know the best (the dentists of the state) will result in greater confusion of the public and our policy makers. Our leadership as members of the UAGD will be looked to by others. Remember that these decisions are made by consensus of individuals and that each individual may be swayed by what we say. ## 2005 Annual UAGD meeting

This year's annual UAGD meeting will feature Howard Farrah as the CE speaker. He will be lecturing on Cosmetic Dentistry and speaks throughout the country. Mark your calendars for September 16. A 118 page clinical study of 125 patients for the removal of nonimpacted teeth completed in December 2000 by Dr. Javier M. Herrera, member of The Department of Oral and Maxillofacial Surgery at Ruprecht Karls Medical University Heidelberg, Germany, showed that tooth removal does not cause noticeable bone loss, but rather it's methodology.

A segment of the documentation shows that 53 patients in Group A were treated with conventional tooth removal procedures found standard among the dental profession. His second Group B of 72 patients were treated with the Ögram System tooth removal technology. #### Fellowship Requirements

1. Current AGD membership for three (3) continuous years (36 months) by September 30 of the year of the Convocation for which application is made, to begin no earlier than the month of dental school graduation; dental license has not been suspended or revoked within the last five years, and is not currently under probation, suspension, or revocation.

2. Completion of 500 hours of FAGD/MAGD-approved continuing education credit, with at least 350 hours earned in

course attendance. Mastership credit begins to accrue on the date that the 500-hours requirement has been met, as

determined by the Council on Dental Education.

3. Successful completion of the Fellowship Examination. The exam may be taken at any time after joining the AGD but must be completed prior to December 31 deadline for Fellowship applications.

4. Attendance at a Convocation Ceremony, held during the AGD Annual Meeting, to receive the award. Successful

candidates are allowed three years following approval to complete this requirement.

#### Activities Accepted for Fellowship Credit **Course Attendence Credit**

A minimum of 350 hours of continuing education course credit is required for the award. Course content must be directly related to the practice of dentistry with the exception that 10 hours are permitted for self-improvement courses.

#### Course credit can be earned for: **1. Scientific Programs**

A) Attendance at courses put on by FAGD/MAGD-program providers. Approved program providers include those

accepted by the Committee on Program Approval for Continuing Education (PACE), intrastate program providers

approved by AGD Constituent Academies, or those approved by the ADA's Continuing Education Recognition

#### Program (CERP).

B) Individual intrastate courses may also be approved by the AGD Constituents.

#### 2. Postgraduate Education

250 hours of course credit may be earned for completion of a one- or two-year ADA-accredited advanced dental

education program (AEGD/GDR/GPR). Credit is permitted for programs completed up to 12 months prior to joining

the AGD. A copy of the certificate is required to receive credit. 3. Federal Dental Service Specialty Rotation Programs

Participation in Federal Dental Service Specialty Rotation Programs earns 1 credit hour for each working day in the

program. A maximum of 200 hours may be applied to the award. 4. Self-Instructional Programs

Up to 150 hours of credit may be applied to the award for completion of FAGD/MAGD-approved audio,

audio/visual, written and other self-instructional programs, provided the program provider verifies satisfactory

completion. In addition to the 150 hours self-instructional credit, 25 hours of credit may be awarded one time only

to members completing the post-test from the FAGD Exam Study Guide

#### 5. Self-Improvement

Up to 10 hours of credit may be applied to the award from FAGD/MAGD-approved self-improvement course taken on or after July 1, 1985

#### Fellowship Award Guidelines

#### Other CE Activities for Credit

1. Teaching and Publications--as listed for Mastership Credit Limitations

Credit Start Dates: Continuing education credit earned after the credit start date may be applied toward Fellowship award.

Credit start dates are assigned upon joining the Academy, as follows:

- 1. January 1, if membership began between January 1 and June 30;
- 2. July 1, if membership began between July 1 and September 30;

3. October 1, if membership began between October 1 and December 31:

4. Date of dental school graduation, if membership began within the first calendar year after graduation;

5. Date of residency completion, if membership began within 12

1- or 2-year AEGD/GPR/GDR.

Subject Category: A maximum of 150 credit hours may be earned in Fellowship Requirements continued-on page 6

#### Mastership Requirements

1. Current membership in good standing in the Academy of General Dentistry at the time of application; dental license

has not been suspended or revoked within the last five years, and is not currently under probation, suspension, or

revocation.

2. Fellowship in the Academy of General Dentistry. Mastership and Fellowship may not be conferred in the same year.

3. 600 hours of MAGD-approved continuing dental education credit, 400 of which must be in participation courses.

Mastership credit begins to accrue on the date that the 500-hour Fellowship Award requirement has been met, as

determined by the Council on Dental Education.

A) The 600 credit hours must be earned in specific disciplines, as outlined under "Subject Category requirements."

B) A participation course is defined as one in which all course participants actively manipulate dental material or

devices, treat patients or otherwise practice skills or techniques under the supervision of a qualified instructor.

The participation activities must represent a minimum of 30% of total course time and must directly address the

educational objectives of the course and be an extension and amplification of the lecture portion of the course.

C)Special Provision: Fellows who submit evidence of completion of a two-year ADA-accredited advanced education

program in general dentistry are required to earn only 300 MAGD-approved credit hours to be eligible for

Mastership, provided the program was completed within 12 months of joining the Academy. These 300 hours

may be either lecture or participation, but may not include credit for teaching or publications. Candidates

applying under this provision must complete one-half the number of credits required in each subject category. A

special GDR-application should be requested.

4. Attendance at a Convocation ceremony, held during the AGD Annual Meeting to receive the award. Successful candidates

are allowed three years following approval to complete this requirement.

#### Activities Accepted for Mastership Credit

#### **Course Attendance Credit**

1. Continuing Education Courses

A) Attendance at courses put on by FAGD/MAGD-program providers. Approved program providers include those

accepted by the Committee on Program Approval for Continuing Education (PACE), intrastate program

providers approved by AGD Constituent Academies, or those approved by the ADA's Continuing Education

Recognition Program (CERP).

B) Individual intrastate courses may also be approved by the AGD Constituents. 2. Residencies

Up to 300 hours of participation credit may be earned for completion of a oneyear, ADA-accredited advanced dental

education program (AEGD/GDR/GPR), provided the program was completed after the date Mastership credit begins to

accrue. The 300 hours of credit are apportioned among the subject categories according to the amount of course time

spent in each subject area. Those applicants who completed a two-year, ADAaccredited general practice residency within

12 months of joining the Academy may apply for Mastership under the Special Provision (Req #3 C).

#### 3. Federal Dental Service Specialty Rotation Programs

Participation in a Federal Dental Service Specialty Rotation Program earns one hour of participation credit for each

working day of the program. A maximum of 200 MAGD hours may be applied to the award for this activity.

#### 4. Self-Instructional Courses

Credit may be earned for completion of audio, audio/visual, written and other self-instructional programs, provided

the FAGD/MAGD-approved sponsor verifies satisfactory completion. A maximum of 150 hours of credit may be

applied to the award for self-instruction courses. In addition to the 150 hours, 25 hours of self-instructional credit

maybe awarded one time only to members completing the post-test from the FAGD Exam Study Guide.

#### Mastership Award Guidelines

#### Other Activities for CE Credit

#### 1. Teaching/Publications

A combined maximum of 150 hours of MAGD credit may be applied to the Mastership Award for the following

activities:

A) Full- or Part-time faculty positions at ADA/CDA-accredited institutions

B) Continuing education presentations put on by FAGD/MAGD-program providers. Original presentations receive

three hours of credit for each hour of teaching. Repeat presentations receive hour-for-hour credit. Credit will be

awarded upon receipt of verification from the program provider. C) Authorship of a published scientific article in a dental or scientific journal;

D) Authorship of a published dental textbook or chapter in a published textbook;

E) Authorship of a case report, technique paper or clinical research report in a dental or scientific journal

published in or after July, 2000.

#### Credit will be awarded as follows:

Published scientific article in a refereed journal .65 hours Published scientific article in a non-refereed journal .40 hours Published dental textbook or chapter in a published textbook .65 hours Published case report, technique paper or clinical research report in a refereed journal .10 hours

Published case report, technique paper or clinical research report in a non-refereed journal .5 hours

#### Subject Category Requirements

A minimum number of credits must be earned in each of the 16 dental subject categories listed below. Of the 'required

minimum' hours needed in each category, a specific portion must fulfill the 'participation minimum' requirements. The

difference between the 'total hours' and 'total required' may be taken from any of the 16 disciplines.
