viewing and implementing policy changes that continue to affect our profession as general dentists. The Academy installed and welcomed our

new President, Dr. Hans Guter, as he delivered an electrifying address bringing back a sense of family and encouraging leaders to help move the organization forward. At the conclusion of the last HOD session, the AGD Board held its first board meeting and approved new council and committee appointments for the new year. Your Region 17 leadership team was well represented at the HOD!



Our AGD Board meets virtually on a regular basis to address opportunities and explore solutions impacting the field of general dentistry. In January seven AGD councils met in Tampa for a joint meeting and collaborated on initiatives to advance the strategic goals of our Academy. During the meeting I served as a Board Liaison to the Dental Education Council and was truly impressed with the amount of work this council has done to bring more educational opportunities to support lifelong learning. Simultaneously at Joint Base San Antonio - Fort Sam Houston, the Association of Army Dentistry and Army Dental Corps will dedicate a bronze sculpture depicting a dental officer, dental assistant and patient in a field setting – highlighting the mission of Army Dentistry, caring for Soldiers in any location, at any time. If you are in the local area, please come out to support this historic event and tribute.

AGD's Scientific Session, the premier meeting for general dentistry, is returning to Caesars Palace Hotel & Casino in Las Vegas, July 19-22. Due to COVID-19, our last meeting scheduled in Las Vegas was held virtually. If you haven't signed up for courses, registration is still open as they fill up quickly. This year the Academy will offer the virtual package including eight lecture courses through a livestream. Region 17 members continue the tradition for serving as speakers for the Summer Fellowship Review Course occurring during the meeting. In addition, many of our federal service members will received their Fellowship, Mastership and LLSR awards at this year's Convocation. This will be a meeting you don't want to miss so register today.

In November, the AGD sent a letter to the House and Senate Committees on Armed Services requesting the Chief Dental Officers of each military branch have two-star or higher rank and that this requirement be included in the 2023 National Defense Authorization Act (NDAA). Maintaining proper oral health care is vital to the readiness of all military branches and is essential to conserving the fighting strength by maintaining force health protection. Oral health care is essential to sustaining combat power on the battlefield and needs to be an equal priority to all other aspects of military health care. As done in the past, AGD is no stranger to proposing this type of legislation and remains at the forefront of advocating general dentists. Consisting of over 40,000 members, our Academy continues to be a strong supporter of its military and federal service members who dedicate their service to our great Nation.

As always thanks for your commitment and dedication to our Academy, profession and country. It is a great time serve when we are needed the most.

# Royal Canadian Dental Corps Newsletter

## Royal Canadian Dental Corps Message

Greetings from Canada! I wish to take this opportunity to update readers on the accreditation status of the Royal Canadian Dental Corps (RCDC) within the Canadian Forces Health Services

(CFHS) and convey the importance and benefits of accreditation in general. The RCDC was accredited by the Commission on Dental Accreditation of Canada following evaluation in 2018-19 and continues to maintain that status through the submission of annual reviews and reports. In addition,

Accreditation Canada (an independent, non-profit, external organization) assessed the RCDC concurrently with the medical branch against system and service excellence requirements that included validation against standards of excellence, interviews with care teams, interviewing patients and stakeholders across the organization and walking through multiple care delivery processes. CFHS received accredited status once again from Accreditation Canada.

Why is accreditation important? Simply put, it demonstrates an organization's commitment to quality improvement by participating in a continuous assessment program against evidence-based standards and practices to ensure the organization is staying up to date with the evolving changing healthcare industry and providing safe, high-quality care.

Through the standards of excellence provided within the accreditation program, it assists organizations in identifying risks and gaps in care delivery programs and processes and provides guidance and recommendations on how to mitigate those risks/gaps in order to reach or maintain a high standard of safe care delivery. When the

standards are applied broadly across an organization such as federal services dentistry, the accreditation process enables standardization along the continuum of care resulting in overall greater patient satisfaction and staff satisfaction because it means no matter where the CAF patient seeks dental care in a military dental clinic, the care should be delivered in the same high quality, standardized manner.

Patients have individual perspectives and expectations regarding what quality care looks like. From that perspective and facilitated by the requirements of the accreditation program, CFHS is embracing the person-partnered care approach and moving towards embedding this approach into all levels and aspects of care delivery in the organization. It is important to understand the fundamentals of the person-partnered care approach do not only include the patient making decisions and participating in their own care, but it broadens out to include the patient having a critical role in establishing health policy and programs. Using this approach, the patient builds their knowledge, skills and confidence to manage their own health, it helps build strong relationships between the patient and the health care provider in order to take part in shared decision making and allows opportunity for the patients to identify improvements in their care.

In summary, accreditation is a driver to help facilitate organizations journey of continuous quality improvement and patient safety. It promotes an organizational culture that focuses on promoting a non-punitive reporting culture to encourage reporting of errors, enhance communication across care teams and contribute to lessons learned to improve overall operational efficiency and reduce patient safety incidents and/or adverse events in the healthcare environment. Throughout the above continuum, my involvement in the accreditation process at both the higher HQ and clinic levels has been a meaningful and enlightening experience which has provided an additional perspective enabling the prioritization of quality improvement activities and mitigating risks within the organization. I encourage all of you to explore and participate in care delivery accreditation processes if given the opportunity in the future.
