Arizona oral cancer walk 2013



On Saturday, April 6, 2013, the fourth annual Arizona Oral Cancer Walk successfully took place at El Dorado Park in Scottsdale. There were over 100 participants, including community members, local dentists and dental assistants and hygienists, dental students, and volunteers.

Free oral cancer screenings, breakfast and refreshments, and survivor stories were shared prior to the 5k walk/run. The first guest suvivor speaker was Christine Brader. Christine is a three-time oral cancer survivor. She is a senior board advocate for The Oral Cancer Foundation. She works at the state level and travels to oral cancer walks around the country to

increase awareness regarding tobacco use and its effects. Our second guest speaker was Kaitlyn Propp, who was 19 years old when she was diagnosed with squamous cell carcinoma during a routine oral cancer screening with her general dentist. She had no history of alcohol or tobacco use. Therefore her presence spoke volumes on the importance of obtaining oral cancer screenings despite age, use of tobacco or use of alcohol. 

EMERGING ISSUES IN THE DENTAL PROFESSION

AFFORDABLE HEALTHCARE ACT

In April 2013, the Health Policy Resources Center at the American Dental Association released "The Affordable Healthcare Act (ACA) Expands Dental Benefits for Children But Does Not Address Critical Access to Dental Care Issues", which is a research brief written by Drs. Kamyar Nasseh, Marko Vujicic, and Amanda O'Dell.

This research brief presents the estimated impact of the ACA on the number of adults and children with dental benefits in 2018 as well as the additional dental visits and spending the ACA is expected to generate. With the ACA, approximately 8.7 million children are expected to gain some form of dental



benefits by 2018 as a result of the ACA, an increase of 15% relative to 2010. This will reduce the number of children without dental benefits by about 55%. Although 17.7 million adults are expected to gain some level of dental benefits as a result of the ACA, almost all of this increase is in Medicaid which varies significantly state to state on adult dental benefits policy. As a result, only 4.5 million of adults are expected to gain 'extensive' dental benefits through Medicaid. An additional 800,000 will gain private dental benefits through health insurance exchanges. Combined, this will reduce the number of adults without dental benefits by about 5%. There is likely to be significant pressure on Medicaid providers within the dental care delivery system. The ACA is expected to generate an additional 10.4 million dental visits per year through Medicaid by 2018.

One challenge with the ACA is that the increase in benefits does not necessarily equate to increased dental care utilization. This is because many current issues such as low provider reimbursements levels and administrative inefficiencies will continue to be issues. Additionally, the increase in benefits will increase the inflow of adults, which will put more pressure on an already pressured dental care delivery system.

ADA ASKS SENATE TO MOVE ON STUDENT DEBT INTEREST

On July 1, the fixed interest rate on subsidized Stafford loans for undergraduates was set to double, from 3.4 percent to 6.8 percent. Most dental students already face heavy debt associated with the next four years; they certainly don't need the added burden of increased interest on their existing undergraduate loans. In a letter to the Senate, ADA President Dr. Robert Faiella and Executive Director Dr. Kathleen O'Loughlin asked senators to keep Stafford loans "at or as close to 3.4 percent as possible and work on a long term solution to bring the graduate loan rates down." "Educational debt



plays a major role in postgraduate career planning," they wrote. "It can influence whether a recent graduate will choose to enter private practice, focus on underserved communities or pursue a career in public service, teaching, research and/or public health." The ADA is also lobbying to keep rates down on graduate school loans. The

Association stresses the role heavy student debt plays in keeping new dentists from setting up practice in underserved communities or pursuing careers in public health. In 2011, the average educational debt per graduating dental school senior was \$180,557.



DENTAL INSURANCE FAIRNESS ACT (H.R. 1798)

On May 2, 2013 - Rep. Paul Gosar (R-Ariz.), one of two dentist members of Congress, has taken the lead in addressing insurance practices that hurt dental offices and patients by requiring plans to allow both coordination of benefits and assignment of benefits. This new bill, the Dental Insurance Fairness Act (H.R. 1798), would require dental plans to allow policy holders to use both their primary and secondary policies to pay for the cost of care. In some states

without coordination-of-benefit laws, plan rules that prohibit this kind of coordination leave the beneficiaries on the hook for a portion of the care provided, notwithstanding the fact that they're paying for two policies.

The assignment-of-benefits provision would allow patients to direct dental plan payments directly to their treating dentists, even non-participating providers. Permitting this would mean that patients would not have to pay out-of-pocket for covered services and then wait to be reimbursed by their dental plans. So far the bill has five cosponsors.

NEW CHANGES AROUND THE COUNTRY

The California Dental Hygiene Committee of the Dental Board of California is proposing rules to approve courses for expanded function dental hygienists. The new rules, proposed on July 5, 2013, set regulations for courses that provide instruction in administration of local anesthetic agents, limited to the oral cavity; administration of nitrous oxide and oxygen when used as an analgesic; and periodontal soft tissue curettage. A hearing for the proposed rules is scheduled for Aug. 21, 2013.

The Georgia Board of Dentistry is now under the Department of Community Health, thanks to the passage of House Bill 132. The bill, which was signed by Gov. Nathan Deal on April 25, 2013, and became law on July 1, 2013, moves both the Board of Dentistry and the Board of Pharmacy from the Secretary of State's Office to the Department of Community Health.

The New Mexico Board of Dental Health Care has adopted new rules regarding licensee's practice management and continuing education. The new rules, adopted on June 28, 2013, change the length of time dentists must consider a patient of record from 18 months to 12 months. The new rules also now allow volunteer activities as part of dental and dental hygienists continuing education. Volunteer service is limited to board or dental hygiene committee approved charitable events that include a post-event survey. Charitable event credits are limited to eight hours per triennial period.

On July 9, 2013, the Massachusetts Joint Committee on Public Health held a hearing on House Bill 2000. This bill, introduced on Jan. 17, 2013, provides for an investigation and study by a special commission on the safety of dental amalgam. No outcome of the hearing is available yet.

Oregon has two new laws affecting dentistry and oral health. Senate Bill 2, which was signed by Gov. John Kitzhaber on June 26, 2013, establishes the "Scholars for a Healthy Oregon Initiative" to provide free tuition and fees for students in health care disciplines, in exchange for student commitment to work in underserved locations after graduation. Senate Bill 436, which was signed by the governor on July 1, 2013, requires coordinated care organizations to include a community health improvement plan strategy for the use of school-based health centers.
